January 22, 2017 BOARD RETREAT

- REPORT OF ACCOMPLISHMENTS FOR 2016
 - Improved attendance at board meetings
 - Policy Manual written, approved and posted on website
 - Improvements in public relations
 - Website position removed from Board; made appointed committee
 - Newsletters set up in Constant Contact
 - QuickBooks set up for financials and to send member invoices
 - Website redesigned with many improvements
 - Established monthly Socials and attendance was up
 - Published and distributed a Member Directory
 - Developed Art from the Attic as fundraiser for arts education
 - Sent and reported on Survey of membership
- MOTION PASSED to discontinue participation in TMA shows because TMA increased booth costs and discontinued collecting sales payments, plus SACA participation is falling.
- RECOMMENDATION from Jury Coordinator for mentoring to make jury results more consistent, plus perhaps a list of rules for jurors with a point-system to evaluate. Should hold juries 2-3 times a year. No Action.
- 2017 GOALS
 - 6-week co-op Gallery
 - survey members once a year
 - 5-year business plan
 - need proof-reading (Janet Burner volunteered)

February 8, 2017

- SHOWS REPORT Tohono Chul will waive their entry fee during the show in February. Tucson Botanical Gardens will host a SACA show September 22-23 but will not waive admission, and charge artists 25%.
- POLICY APPROVED to refund show entry fee to anyone who withdraws from show up to two weeks before the event only if there is a wait list replacement. Within the two-week window, no refunds will be given to withdrawals.
- SOCIALS REPORT noted disappointing attendance at events.
- AGREED to focus only on four quarterly Socials per year to include the Annual Membership meeting and the holiday party.
- PR REPORT Theresa Poalucci donated an Art from the Attic ad in Oro Valley Voice which reaches 36,000 households

March 8, 2017

- SHOWS REPORT stated a SACA net gain for the Tohono Chul show, which was considered successful for both Tohono Chul and SACA.
- SHOW POLICY QUESTION presented by Laura Stiltner about changing prices during a show. Clarified that price tags and inventory sheets may be adjusted discreetly outside show hours to avoid the appearance of markdowns, discounts or price negotiation.

April 12, 2017

- MEMBERSHIP to send a new form for Directory entries in May with a more limited choice of entries, including Teacher, Student, Juried. Will postpone a Survey until 2018.
- SOCIALS REPORT TMA event with a docent tour had 17 attendees. Next socials at Glennda Neff's and Janet Burner's homes.

May 10, 2017

- MEMBERSHIP REPORT Constant Contact price went up to \$70, and will be questioned.
- WEBSITE REPORT donations may now be made through the website

August 9, 2017
